G. Regional CASM (Nell Hoey)

Karla has a CASM contact for each county but Pine County. Nell did e-mail her Sheriff Cole's e-mail address. Once the contact list is complete Karla will send it to the state for passwords and hopefully training.

H. User Committee (Steve Olson)

- At the last meeting a majority of the time was spent discussing the standards regarding the STR. Will be putting standards together and presenting to the RAC at the March meeting.
- Representatives for the User Committee and Owner and Operator Committee need to be appointed from Pine County.

I. Owners and Operators Committee (Bill Bernhjelm)

- One issue of concern regarding the STR is the cost of insurance, maintenance and licensing of trailer. It has been proposed that a lump sum payment be made to each of the regions that are hosting the equipment in the amount of \$12,500. This should cover these costs for about 5 years. This will have to be approved by the Statewide Radio Board.
- The cache radios have already been purchased and have a three year warranty. They are waiting on the counties to decide on programming format before programming the radios. The trailers will not be delivered until approximately August and will have separate training required for them.
- Cost of initial set up and a yearly exercise (drill) can possibly be funded through current grants. Policy decision needs to be made on this.

IV. OLD BUSINESS

A. ARMER Update (Tim Lee)

- Oshawa, Whipolt, Draper (Cass County) a T1 has been assigned into those sites this week. Should be on the air by next week.
- Sandy Lake; working on tower in the next couple weeks
- Ogilvie, Day, Big Falls, Bena; Towers under construction
- Nickerson, White, Mizpah, Loman, White Pine, Glen, Logan; bids that are ready
- Received consol equipment for state patrol. Plans are to transition northern part of the state to ARMER system by July 1. As they transition they will also keep up the VHF channel. The VHF mobiles will be kept in squads until the end of 2012.
- Interop VHF contract and equipment is in place to build the network. Expecting equipment to be available in next month or two. Will start work in Rochester area.
- The first week in May, Motorola will upgrade the system. Currently at 7.7 and will take it to 7.9. Upgrade will take approximately 2-3 weeks. There may be some outages for Itasca County as the equipment is upgraded.
- The latest revision of Change Management Process has been passed out. Please look it over and send comments back to Mark Gieseke.
- South Central Region will be forwarding a request to our region to program the NE Regional TACs into some of their radios.

V. NEW BUSINESS

A. NE Regional Strategic Technology Reserve Participation Plan (Bruce Hegrenes)

DECN brought the proposed Regional Participation Plan to the OTC last week. Some sort of agreement is needed with the State Radio Board for the region. St. Louis County agreed to be the System Administrator for region as well as point of contact for the equipment. Now needs to be sent to the RRB for approval.

B. Mileage Rates (.51 cents currently/need to adopt and move to RRB)

Current bylaws indicate mileage rate of .50 cents. Presently, the federal government has changed that to .51 cents. Proposal is made to recommend to RRB to change bylaws to recognize and adopt Commissioner's Plan as expense reimbursement plan. This plan is kept up to date and has a website that explains all the expenses that are allowable under state statutes.

Nell will forward the sample letter to the RAC/RRB, and Marcus encourages everyone to write to their representatives.
